# General

- **IED timeline:**
  - Publication of the revised IED on 15 July 2024
  - Entry into force (EIF) on 4 August 2024 (= the clock starts for a number of IA / DA).
- **General principle for developing IA/DA and other documents:**  
**consultation of stakeholders (written comments, workshops, etc.)**

Revised BREF Guidance	Article 13(1a)	1 July 2026	Orientation document in September 2024 – first draft of revised BREF Guidance end 2024
Information reported to COM under the IED	Article 72(2)	5 August 2026	Technical work started, consultations on a background document in Q1 2025
Compliance assessment method	Article 15a	1 September 2026	Contract to support COM to be launched in September 2024
Livestock Uniform Conditions for Operating Rules	Article 70i	1 September 2026	Technical work to be launched with expert group October/November 2024

Methodology to assess disproportionality when derogations from AELs are being considered	Article 15(5)	No deadline	First draft end of 2025 (tentative)
Methodology to assess env./economic impact when derogations from AEPLs are being considered	Article 15(6)	No deadline	First draft end of 2025 (tentative)
Detailed arrangements of INCITE	Article 27a	No deadline	First draft planned end 2025, factoring in lessons learned from first months of operation

Implementation of livestock operating rules	Article 70b	11 years after entry into force of operating rules

Guidelines on livestock aggregation rules	Article 70b	5 August 2028	
Best practices in e-permitting	Article 5(4)	No deadline but e-permitting required by 31 December 2035	Contract to support COM to be launched in October 2024
Appraisal of environmental risks for site visits	Article 23(4)	No deadline	COM working with IMPEL on a first draft – to be ready around summer 2025
Criteria to grant emergency derogations	Article 15(7)	No deadline
