to the Call for award of additional funding to already contracted Projects**

## 1. OBJECTIVE OF THE GUIDANCE

The SK-Climate Programme Operator amends by this Guidance Call for award of additional funding to already contracted Projects, financed from the EEA Grants/Norway Grants and the State Budget of the Slovak Republic, launched on 10.01.2023 as follows:

- Extension of deadline for the 4<sup>th</sup> round of the Call,
- Update of available allocation of the Call.

The amendment of the Call concerns these following basic and specific conditions:

### Justification of the amendment:

The SK-Climate Programme Operator amends the Call conditions in response to the expressed interest of the Project Promoters of already contracted Projects so far within the closed first three rounds and expected interest of Project Promoters of already contracted Projects in the 4<sup>th</sup> round of the Call following the current state of public procurements within these Projects.

The objective of the Call amendment is to provide sufficient time to Project Promoters of already contracted Projects for finalization of their public procurements and submission of the additional funding requests.

- Call for award of additional funding to already contracted Projects.

### **3. EFFECTIVE DATE OF AMENDMENTS AND IMPACT ON ADDITIONAL FUNDING REQUESTS SUBMITTED**

Amendments resulting from this Guidance shall entry into force on 24.10.2023.

Amendment is without impact on the conditions for eligible applicants in the original text of the announced call. Therefore, the impact on the additional funding requests submitted so far is not expected.
